### NOTIFICATION

**Delhi, the 30<sup>th</sup> July,2007**

**No. ACI/PC/CI/2/2007/171.**- In exercise of the provisions of Section 20 read with clause (p) Section 2 of the Micro, Small and Medium Enterprises Act,2006 (No. 6 of 2006), the Lt. Governor, National Capital Territory of Delhi is Pleased to constitute the "Micro, Small and Medium Enterprises Council" for National Capital Territory of Delhi, with the following as members:-

1. Secretary & Commissioner of Industries,  
Government of National Capital Territory of Delhi – Chairperson.
2. Secretary, Law or his Representative,  
Government of National Capital Territory of Delhi. – Member.
3. General Manager, Lead Bank of Delhi i.e. State Bank of India – Member
4. A Representative of Federation of Indian Industries (CII) – Member
5. General Secretary, Okhla Industries Estate Association – Member
6. Joint Commissioner of Industries (Policy) Department of Industries, Government of National Capital Territory of Delhi Will act as Secretary to the Council

Since the members of Industry Facilitation Council are being nominated by designation, the vacancy that would arise on account of any member leaving his office would be treated as filled up automatically by his successor.

The Council will perform following functions:-

1. To entertain reference received under sub-section (1) of Section 18 of the aforesaid Act, with regard to any amount due from the buyer for the goods supplied or services rendered by the supplier;
2. The Council shall either itself conduct conciliation in the matter on reference placed before it or seek the assistance of any institute or center providing alternate dispute resolution services by making a reference to such an institution or center, for conducting conciliation. The provisions of Sections 65 to 81 of the Arbitration and Conciliation Act, 1996 shall apply to such a dispute as if the conciliation was initiated under Part III of that Act.
3. When such conciliation is not successful and stands terminated without any settlement, the council shall either itself take up the dispute for arbitration or refer it to any institute or center providing alternate dispute resolution services by making a reference to such an institution or center, for such arbitration and the provisions of the Arbitration and Conciliation Act, 1996 shall then apply to the

dispute as if the arbitration was in pursuance of an arbitration agreement referred to in sub-section (i) of Section 7 of that Act;

4. The Council shall have jurisdiction to act as an Arbitrator or Conciliator in a dispute between the supplier located within its jurisdiction and a buyer located any wherein in India.
5. The Council shall decide reference received by it within a period of ninety days from making of such reference;
6. The Chairperson or any other officer authorized by him shall forward the proceedings of every meeting of the Council including annual progress report of the Council to the Member-Secretary of the Advisory Committee constituted under sub-section (3) of the Section 7 of the Act.
